



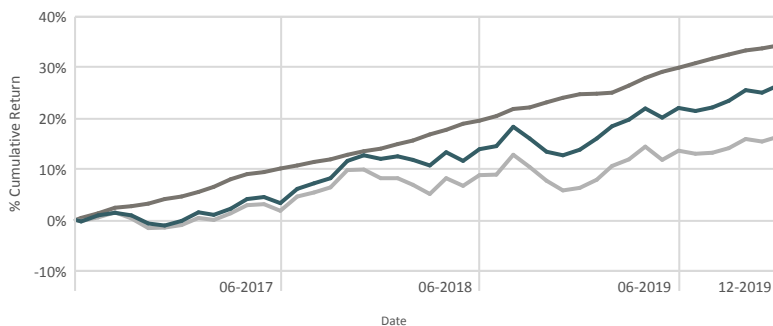
INVESTMENT OBJECTIVE

The Wealth Associates BCI Moderate Fund of funds is a medium risk profile portfolio with the objective to provide investors with a moderate long term total return.

INVESTMENT UNIVERSE

The portfolio is a medium risk profile and has investment exposure across multiple asset classes. On a look through basis, the portfolio's equity exposure will ranging between 0% and 60% of the portfolio's asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes. The underlying portfolios may invest in, amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds, other interest bearing instruments and financial instruments.

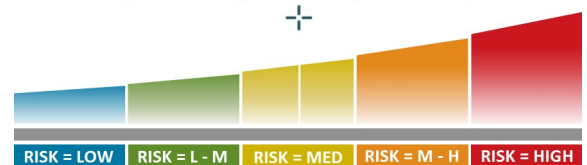
